



TERMS AND CONDITIONS (TnC) **TO “PASTOVILLA INNOVATIVE CHEF CONTEST”** **{WIDELY KNOWN AS ‘PIC CONTEST’}**

THE “PASTOVILLA INNOVATIVE CHEF” IS ORGANIZED BY MANDALAS IMPRESA RETAIL PVT. LIMITED (THE PROMOTER).

1. By submitting an entry to the “PASTOVILLA INNOVATIVE CHEF” (“**Competition**”):

(Size-5.91 MB maximum & 3581px x 4013px) in JPEG format and a video of the same dish (1 minute (1024px x 1024px HD) in Editable format). Sample of video will be made available by the promoters at appropriate time.
- c) Review & selection of dish by Panel of our Judge Chefs and Food Bloggers
- d) Selection of best 100 contestant to start the Contest in person.
- e) Intimating selected 100 contestants, their names and dish name and pictures will be shown on brands social media handles including YouTube channel.



Process goes as follows:

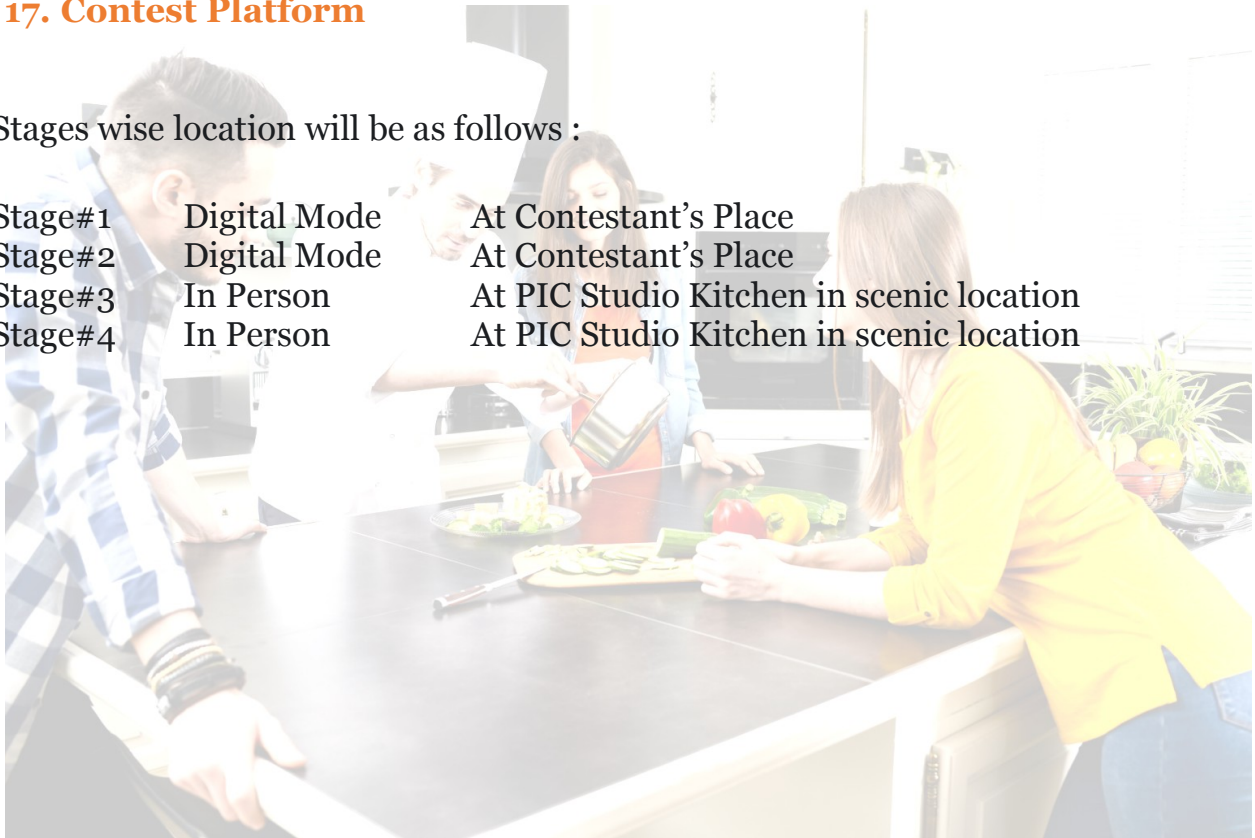

Personal Data

39. General

40. 42. THE PROMOTER'S DATA POLICY
